# Proposed Addition to Participation Limitations to Provide Limitations on Competitive Cheerleading Participation

(Action Item)

Question: Should the Delegate Assembly adopt and amendment to add competitive cheerleading participation limitations to OSAA Regulations?

RATIONALE: The Oregon Cheerleading Coaches Association (OCCA) is concerned that some schools are allowing individual competitive cheerleading participants to perform on teams in multiple levels (varsity, JV, etc.) at the same cheerleading competition. Just as OSAA rules place limits on the number of quarters or innings of participation allowed in a certain time period for athletes in “traditional” athletics (i.e. five quarters per day in basketball), competitive cheerleaders should also be limited.

OCCA recognizes, however, that there may be some unusual circumstances (such as an injury or family emergency of a varsity team member) when it is necessary and appropriate for a JV cheerleader to participate at a competition as a substitute for a missing varsity cheerleader. This proposed rule allows such a substitution without sacrificing the opportunity for performance by the JV team at the same competition due to the loss of a team member, but limits such substitutions to a maximum of twice per school year per JV cheerleader.

The OCCA does not believe that there are any circumstances under which it would be appropriate for a varsity cheerleader to participate on a JV performance at a competition.

### 4. **Competitive Cheerleading.**

- A. **Individual. A JV cheerleader may participate on both the varsity and JV performances at the same cheerleading competition no more than twice each school year. Under no circumstances may a varsity cheerleader participate on a JV team performance at any cheerleading competition.**
