Subject: March 29, 2021 Clarifications/Updates

The OSAA Staff plans to send regular updates to schools with clarifications based on recent communication with the Oregon Health Authority (OHA) regarding common questions for indoor and outdoor recreation policies and protocols.

The OHA has clarified their guidance regarding outdoor field capacity limits, aligning them with the numbers/percentages under Outdoor Fitness Establishments.

## FIELD CAPACITY GUIDANCE

- Per the updated Sector Risk Level Guidance Chart and Maximum Occupancy Resource for COVID-19:
  - o Spectators in the stands are considered separate from the players, coaches, etc. on the field.
  - For field capacity, refer to the numbers/percentages under Outdoor Fitness Establishments on the Sector Risk Level Guidance Chart.
  - on the Sector Risk Level Guidance Chart.
  - Spectators must be in an area with separate entrances, exits and restrooms from the sports participants that is at least six (6) feet from the sports activities.
  - A physical distancing monitor must be assigned to ensure compliance with the maximum occupancy limits for spectators.
  - o Face coverings and contact tracing requirements remain in effect.
- Outdoor Full Contact Sports (Football)
  - Extreme Risk 120 maximum field capacity for coaches, officials, players, etc.; Spectator Capacity 50 maximum in each designated spectator area.
  - High Risk 120 maximum field capacity for coaches, officials, players, etc.; Spectator Capacity 15% maximum occupancy.
  - Moderate Risk 25% of maximum field capacity for coaches, officials, players, etc.; Spectator Capacity –
     25% maximum occupancy.
  - Lower Risk 50% of maximum field capacity for coaches, officials, players, etc.; Spectator Capacity –
     50% maximum occupancy.
- Outdoor Non-Contact, Minimal/Medium Contact Sports
  - Extreme Risk 50 maximum field capacity for coaches, officials, players, etc.; Spectator Capacity 50 maximum in each designated spectator area.
  - High Risk 15% maximum field capacity for coaches, officials, players, etc.; Spectator Capacity 15% maximum occupancy.
  - Moderate Risk 25% maximum field capacity for coaches, officials, players, etc.; Spectator Capacity –
     25% maximum occupancy.
  - Lower Risk 50% maximum field capacity for coaches, officials, players, etc.; Spectator Capacity 50% maximum occupancy.
