#### Article 4.1 - Delegate Assembly

- **4.1. Composition**. The Delegate Assembly shall be composed of 40 41 representatives:
  - **4.1.1.** Thirty-five representatives elected by the members of regular athletic districts.
  - **4.1.2.** An athletic director representative elected by the Oregon Athletic Directors Association.
  - **4.1.3.** An activities director representative selected by the OSAA Student Activities Advisory Committee.
  - **4.1.4.** A school boards representative elected by the Oregon School Boards Association.
  - 4.1.5. A member of the OSAA Equity and Diversity Advisory Committee.
  - **4.1.6.** A non-voting advisory coach representative elected by the Oregon Athletic Coaches Association.
  - **4.1.7.** A non-voting advisory **An** official representative selected by the Oregon Athletic Officials Association.
  - **4.1.8.** The Executive Director shall be an ex-officio, non-voting member of the Delegate Assembly.

- 5.1. Composition. The Executive Board shall be composed of 13 15 elected members and shall consist of one elected representative from each classification, plus the following representatives appointed by the Executive Board: one a 6A/5A/4A at-large representative appointed by the Executive Board, a 4A/3A atlarge representative, and one a 3A/2A/1A at-large representative appointed by the Executive Board, a representative of the Oregon School Boards Association, a representative of the Oregon Athletic Directors Association, a representative of the OSAA Student Activities Advisory Committee, an activities director representative, a representative of the OSAA Equity and Diversity Advisory Committee, a non-voting advisory coach representative of the Oregon Athletic Coaches Association, and a non-voting advisory an official representative of the Oregon Athletic Officials Association.
  - 5.1.1. The 6A/5A/4A, 4A/3A, and 3A/2A/1A at-large representatives shall be appointed by the members of the Executive Board prior to the term of office to be filled. Criteria to be considered by the Executive Board in making these appointments may include, among others, geographic, gender and ethnic representation on the Executive Board.
  - 5.1.2. The following affiliated groups shall each submit information for three candidates to the Executive Board for consideration prior to the term of office to be filled. The Executive Board shall appoint one of the candidates submitted for each affiliated group. Criteria to be considered by the Executive Board in making these selections may include, among others, geographic, gender and ethnic representation on the Executive Board.
    - a. Oregon School Boards Association (OSBA)
    - b. Oregon Athletic Directors Association (OADA)
    - c. OSAA Student Activities Advisory Committee
    - d. OSAA Diversity and Equity Advisory Committee
    - e. Oregon Athletic Coaches Association (OACA)
    - f. Oregon Athletic Officials Association (OAOA) shall be elected by their organization.
  - 5.1.3. An athletic director representative shall be elected by the Oregon Athletic Directors Association (OADA).
  - **5.1.4.** An activities director representative shall be selected by the OSAA Student Activities Advisory Committee.
  - 5.1.5. A coach representative shall be elected by the Oregon Athletic Coaches Association (OACA).
  - **5.1.6.** An officials' representative shall be selected by the Oregon Athletic Officials Association (OAOA).
  - **5.1.7.** The Executive Director shall be an ex-officio, non-voting member of the Executive Board.

FROM: Brad Garrett, Assistant Executive Director SUBJECT: OSAA Football Ad Hoc Committee Update

The Football Ad Hoc Committee conducted its fourth public meeting related to Football placements during the 2022 – 2026 time-block on February 2, 2022, at the Holiday Inn Wilsonville with public testimony streamed live via the OSAA YouTube channel. When finalized, Committee recommendations will be forwarded to the OSAA Executive Board for review and adoption.

OSAA staff provided a summary of 26 pieces of correspondence received after the last meeting. The Committee received online testimony from seven individuals in total representing six different schools. The group then convened into a work session to continue developing recommendations.

#### **Draft League/Special District Configurations by Classification**

The Committee reviewed and reached consensus on a second draft of all school placements and alignments for the 2022-2026 time block. A considerable portion of the work session was dedicated to reviewing notifications from schools who have met criteria and indicated they would like to exercise the option either to stay in their current classification or play down. Adjustments to alignments were required within several classifications based on school movements.

Kennedy High School and Salem Academy have notified the group that they would like to play-up to the 3A classification level. The Committee is supportive of allowing teams to play-up in Football when requested. Any school considering playing up a classification has until Monday, February 14 to notify the Committee of their intent. After that date the group has determined any further requests for a different placement should be directed to the OSAA Executive Board for review and consideration.

A complete summary of the notifications received, and the draft school placements are included with this update.

#### **Bracket Structure/Allocations**

The Committee started the process of addressing bracket size and allocations in each classification. The table below summarizes their current positions at all levels.

The committee discussed the 6A classification bracket options but have not reached consensus on how to move forward. Results from a survey conducted by the OACA/OADA does indicate that 6A schools who responded favor modifying the current 32-team bracket in some format.

The following models were discussed.

#### 32 Team Bracket Options:

- Example A: No Change current 32-Team Bracket
- Example B: Eight-team Open Division Bracket using the top eight 6A teams in the rankings. The 6A schools ranked #9-32 would play in the 24-Team 6A Bracket with teams ranked #9-16 receiving a first-round bye.
- Example C: 6A schools ranked #1-24 would play in the 24-Team Bracket with teams ranked #1-8 receiving a first-round bye. Teams ranked #25-32 would play in an 8-Team Bracket.
- Example D: Two 16-Team Brackets with #1-16 in Bracket A and #17-#32 in Bracket B.

#### **24 Team Bracket Options:**

Example A: 24-Team Bracket with teams ranked #1-8 receiving a first round bye

In 32-Team Bracket Examples B, C, and D when two brackets are formed the awarding of a State Championship to the winner of each bracket continues to be under discussion. The Committee requests that 6A schools provide additional feedback on which option they prefer and why, plus thoughts on whether multiple Championships are merited within the 6A ranks. The goal is to finalize the bracket type and allocations at the group's next meeting.

#### **Changes to Season Length:**

The Committee received testimony in support of extending the season length by one week to allow for playing nine games in 10 weeks. With the extension, the testimony indicates that it could potentially address issues such as allowing additional flexibility with scheduling considering the impact of odd numbered leagues, easing the burden on officials by spreading the same number of games over a longer period of time, helping with transportation issues, and allowing for medical or environmental cancellations to be rescheduled.

Based on feedback from a survey to Athletic Directors and coaches, the Committee sees the only viable way to achieve that extension is by adding another week to the end of the season. At this time the Committee is not in support of that change but will discuss it further at their next meeting.

#### **Recommendation Summary as of this point:**

#### 2A, 1A Structure/Game Type

- Recommends that 2A schools (ADM 75 145) play the 9-player game.
- Recommends that 1A schools (ADM 74 61) play the 8-player game.
- Recommends that 1A schools (ADM 0 60) play the 6-player game.

#### **6-Player State Championship**

The group fully supports adoption of the 6-player game and is encouraging the OSAA State Championship Committee to recommend conducting an OSAA State Championship for 6-player teams.

#### **Placement Criteria:**

- Schools requesting a lower classification for the first time must have had a 2-year in-class winning percentage below 22%.
- Schools previously playing at a lower classification requesting to remain there must have had a 2-year in-class winning percentage of less than 67% and have not won an OSAA playoff game.
- Any school approved to remain down or has opted to play down that has an in-class winning percentage of 67% or higher and/or advances beyond Round 1 of any OSAA Football State Championship will automatically be moved back up for the following season.

The OSAA staff will provide a committee update, like this one, to all superintendents, principals, athletic directors, and football coaches following each meeting. As far as Brookings specific is concerned, we would prefer to be with the Medford schools for travel (seat time) purposes. One game with Lakeview (which would likely end up only once per year and traveling there every other year) isn't as bad as several trips to Douglas county for us.

Boys: once again we would very much prefer to be with the Medford schools for travel reasons. 6 trips to Douglas county (3.5-4 hours away) is a lot to ask for our kids when there are 6 schools with 2.5 hours away in district 8. This also balances out the two league to 10 and 9.

Please consider these changes as soccer, which is a huge draw for kids in our community) will likely suffer lower turnouts each year if total travel remains long and not as competitive.



#### To whom it may concern:

Banks HS soccer is a relatively new sport to Banks and it has been a struggle to be competitive in this sport. In the Cowapa league, Banks was able to compete with schools like Tillamook, Seaside and Astoria. We would most of the time lose but these games were competitive. Our contests with Valley Catholic typically were very one sided and we have never defeated Valley Catholic. Valley Catholic, like many other private schools in our region, are very established and successful in soccer. We don't look like Valley Catholic and we definitely don't look like OES, Catlin Gabel, PAA, Riverdale, etc....

We understand with our move to 3A there would more than likely be Special Districts in many of the sports. What we didn't envision however was being placed in Special District 1 for soccer where most of the schools are private and are some of the best in the state, regardless of classification.

If we are wanting to continue to build any kind of momentum, we feel that Special District 2 gives us a better chance to build a program. Most of the schools in this league look like us (Yamhill-Carlton, Amity, Dayton, Gervais, Taft, Kennedy). I know this would mean more travel for us but it is a price we are willing to pay to give our kids a chance to be part of a program moving in the right direction. I worry being in Special District 1 for the next 4 years could be really detrimental to our soccer program.

I would like to thank the OSAA Executive Board for hearing my proposal and considering moving Banks from Special District 1 to Special District 2. Thank you for your time.

**Subject:** Banks Boys Soccer Request for Placement: Special District 2

Hi Kris,

I wanted to reach out to provide some individual placement feedback for Banks and to request that we be considered for a move to Special District 2.

As I look at the proposed placement in Special District 1, this is a tough fit for our program. We're coming off of a 4 year run of 1 win, 1 win, 2 wins and 2 wins. Many of the SD1 schools are private schools with soccer specific facilities and lack a football program for their fall sports. As I look at Special District 2 these schools are much more similar to ours with smaller towns, and shared fall sports resources.

Competitively and demographically I feel like Special District 2 would be a much better fit for our athletes and our program. This would also balance the sizes of the Special Districts to 9 each for SD 1 and SD2 (co-ops were listed individually on the proposal). This would align us with our closest geographic league opponent in the Coastal Range, Yamhill-Carlton. And finally I also believe travel times would be better or even equivalent for us as we'd stay out of the cross-town metro commute. For example our trip to Milwaukie last year took 1 hour and 45 minutes in traffic for a 6pm kickoff.

We've been able to grow our participation in Boys Soccer to 36 athletes last year (all-time high), and this allowed us to offer a JV team. We're projecting similar numbers this next year, and I'd love to be able to keep the participation momentum going as we are projected strong youth numbers in future years. I'm concerned however that a lineup of league opponents that have a combined 8 state titles in the past 10 seasons, would negatively impact our ability to grow this program and to retain athletes.

Ironically the best fit for my program is actually the 4A Cowapa where we project to be extremely competitive and have some great rivalries going with these communities from the youth level all through to high school.

For all of these factors I'm requesting Banks Boys Soccer be moved from Special District 1 to Special District 2.

I also have some overall feedback regarding the proposal (outside of our individual placement). I know it might be a tad late in the process and I apologize in advance as I was only recently made aware of the proposed placements this past Friday. I'll send this to you in a separate email.

Hi Kris,

I wanted to provide some analysis and feedback regarding the current proposal. Most notably due to the large number of co-opted schools that are listed as individual programs, and the subsequent impact that this has on Special Districts placements for 3A, 2A and 1A schools for Boys Soccer in the Fall of 22. It may be too late in the process to consider such a major change from the current model. My goal is not to create more work for the committee. I only became aware of the proposed districts last Friday and wanted to offer solutions to potential challenges or issues as I became familiar with the structure of the proposed districts.

The motivation for these proposals is to more closely align to the mission of the current 6 classification model with respect to both classification sizes and district sizes. Both of the submitted proposals are with the intention to achieve better parity, and to create opportunities for schools to play at or near their classification level for district competition. It should also be pointed out that the current OSAA proposal contained a high number of co-op schools as individually listed programs, and their placement in the model will already need to be reworked. Addressing these co-ops reduces the total count of schools by 14, and leaves one of the proposed Special Districts with an actual count of only 5 schools and another with 6.

Other initial observations regarding the current proposal from the OSAA are that it creates several potential tensions with: number of league games, scheduling of non league games, imbalance of class distribution by district, unnecessarily breaks apart existing leagues, and it potentially creates inconsistent or unclear rankings calculations with a subsequent impact on potential playoff / championship alignments. Although it isn't clearly stated within the proposals submitted today, some thought was given to the placement of co-ed teams, as well as the impact of co-ed placement with boysonly teams, the rankings calculation(s) and the championship play.

Finally, I believe that the imbalances of the current proposal are likely to impact participation numbers at some schools. Especially for those in districts without schools at their own classification level.

Again I recognize that you are nearing the end of the line and voting on final adoption so if it is simply too late for this contribution I understand. My goal was not to disrupt, it was to help.

#### 9.6. Student Activities Advisory Committee.

- 9.6.1 Charge. The Committee shall serve as a conduit for open communication among representatives of the activities and the school representatives and staff of the OSAA. The Committee shall not be a policy making body but shall serve in an advisory capacity to the Executive Board, Delegate Assembly and staff of the OSAA. The Executive Board will not consider any recommendations from the Dance Drill Coaches Association (DDCA), Oregon Cheerleading Coaches Association (OCCA), Oregon High School Speech League Coaches Association (OHSSLCA) and Oregon Music Educators Association (OMEA) without the support of the Committee.
- **9.6.2. Composition**. The Committee shall be composed of two representatives of each of the OSAA sponsored activities cheer, dance, music and speech.

Committee members shall be current high school employees. The Activities Representative to the OSAA Executive Board shall be an ex-officio member of the Committee.

- **9.6.3.** Term. The term of office for a member of the Committee shall be three years. A member shall not serve more than two consecutive terms. A member who is elected to fill a vacancy shall be eligible for up to two full three-year terms starting with the first meeting after election.
- **9.6.4. Meetings**. The Committee shall adopt an annual schedule of meetings based upon the issues under consideration. The schedule shall include an appropriate number of meetings in which to conduct the business of the Committee.

#### Proposal to Amend Article 3.3.1 (a) – Full Membership Dues

**QUESTION**: Should the Executive Board, per a recommendation from the Budget Committee, increase the full member school annual dues by \$250 starting with the 2022-23 school year?

#### Article 3.3 - Dues

- **3.3.1.** The Executive Board shall establish procedures relative to payment of membership dues and special fees for championships.
  - (a) Full Membership Dues. Full Member school dues are \$1,250 \$1,000, plus \$85 for each OSAA sponsored activity in which the school participates, payable on or before October 15 of each school year.
  - (b) Associate Membership Dues. Associate Member school dues are based on the number of students attending the Associate Member school (\$100 for 1-100 students; \$250 for 101-500 students; \$500 for 501+ students). Associate Member school students are not eligible to practice or participate in a contest until the Associate Member school is listed on the OSAA website.
- **3.3.2.** If a member brings an administrative or judicial challenge to any Regulations or Rules of the Association and/or a final determination of the Executive Board or the Eligibility Appeals Board, and the Association is the prevailing party, the member shall be assessed a membership surcharge equal to the Association's attorney fees and costs actually incurred in defending such action, whether at the administrative or trial court level or on appeal or discretionary review.
