SUBJECT: OSAA Officials Fee Review Committee – Organizational Meeting

The Officials Fee Review Committee conducted an organizational meeting via web conference on March 16, 2022. The constitutionally mandated purpose of this Committee is to make recommendations to the OSAA Delegate Assembly for adoption in October 2022. These recommendations will consider items involving fees paid to individual officials, commissioners, or Local Associations. This includes game fees, mileage, per diem, check writing fees, commissioner fees, or any other type of service fee provided.

The Committee reviewed the charge and went through a history of past committee recommendations involving both regular season officials' fees and supplemental fees charged to OSAA member schools. The Committee also went through all of the supplemental material. The Committee agreed upon the following meeting schedule all will be via web conference (Zoom):

The Committee discussed topics in which they would like feedback:

- Fee structure being another 4-year time period
- Equalization of a single Varsity game fee as opposed to having one for 6A-5A-4A. and one for 3A-2A-1A
- Increasing the sub-varsity game fee
- Adjusting the mileage fee to the IRS rate
- Creating a fee for schools who have multiple schedule changes throughout the season

The OSAA staff will provide a Committee update, similar to this one, to all officials associations, superintendents, principals, and athletic directors following each meeting.
