SUBJECT: 2025 Softball Reminders

Included within this memo are reminders regarding OSAA policies and NFHS rules specific to softball that each coaching staff should review as we begin a new season. The links provided will take you directly to more detailed information regarding that specific reminder. Each school offering softball should have received one copy of the NFHS Softball Rules Book from the OSAA, and if your Athletic Director has your email address listed on the OSAA website under your school, you will be able to have one NFHS eBook of the rules. If your school didn't receive your copy, please let me know. Feel free to contact me if you have questions and best of luck this season!

GENERAL INFORMATION

The 2025 OSAA Softball Plan Book is available on the OSAA website. This plan book contains information regarding important season dates, NFHS rules information, OSAA softball rules and policies, state championship information and qualifications, etc.

Game Balls

Schools are reminded that per NFHS Softball Rules, softballs must include NFHS, COR, and Compression stamps to be legal for high school competition. This includes all levels of play (Varsity, JV, JV2, Frosh). For the regular season, any brand of softball is legal provided it has the required marks. At no time are softballs required to have an OSAA stamp. During the OSAA state playoffs, teams are required to use the Wilson A9011 B-SST, **poly center**.

Field Markings and Game Preparation

Schools shall have fields properly marked before a game begins. This includes all appropriate lines for batters' boxes, coaches' boxes, the catcher's box, foul lines, etc. It is recommended that all outfield fence signs are properly secured to the fence and off the ground.

Invitational Tournaments with Game Time Limits

- a. If fewer than 4 and 1/2 or 5 innings have been played, or the game is ended, and the score is tied, the game is removed from both team's schedules and another contest may be scheduled with a different opponent. If a game is scheduled between the same two schools at a later date, it must be continued from the point of interruption.
- b. If 4 and 1/2 (home team ahead) or 5 innings have been played and the score is not tied, the contest is declared an official game.

Game Ending and "Speed-Up" Procedures

All Levels: 15-Run (after 3 innings.) and 10-Run (after 5 innings.) Rule is in effect.

<u>Sub-Varsity</u>: Time Limit is allowed, per league adoption. NOTE: A maximum number of runs per inning limit are allowed only at the JV/JV2/freshman level per league adoption.

Score Differential: If a 15-run score differential occurs at the completion of three full innings or a 10-run score differential occurs at the completion of five full innings or anytime thereafter, the game shall be terminated and considered a completed game. NOTE: if agreed upon by both coaches, once a softball team has reached a 15-run lead after three innings they may continue to play. The exception to allow flexibility with this rule needs to be addressed prior to the contest during the pre-game conference when both head coaches and umpires are present. The mandatory score differential rule of 10-runs after five full innings is still in effect.

Batting Practice During Games

No team involved in the game may take batting practice of any kind, even in a batting cage, once the game has started. Other teams not involved in the game cannot interfere or impede the game in progress. If the sounds of batting in the cage simulate the sounds of the game, (i.e. batted balls) it is not allowed. If the facility has doors that can be closed, and/or the game umpires agree that the sounds don't interfere with the game in progress, it is permissible.

Courtesy Runners

When a player enters as a courtesy runner, it counts as an inning played for that individual.

Pre-Season Practice Limitation Rule for Pitchers and Catchers

Rule of Two

The Practice Limitation Rule (Rule of 2) for the 3A, and 2A/1A Classifications allows softball coaches to begin pitching instruction and throwing workouts with pitchers and catchers only (maximum of eight total per day) two weeks prior to the Spring Sports First Practice Date (February 13, 2023). The 6A, 5A and now 4A classifications are still following the Pilot Program for the Practice Limitation Rule.

Lightning Safety Guidelines

The OSAA has made a concerted effort to educate member schools and officials associations regarding the suspension and restarting of practices and contests based on the presence of lightning or thunder. Once thunder is heard or a cloud-to-ground lightning bolt is seen, all personnel, athletes and spectators should evacuate to available safe structures or shelters.

2025 NFHS NEW RULES:

1-8-6: Exception & Penalty A high school softball coach is now able to use electronic devices in the dugout for one-way communication to the catcher while the team is on defense. The penalty from Rule 3-6-11 was added to Rule 1-8-6 as well, with violators subject to ejection unless the offense is ruled to be of a minor nature.

3-6-11: This rule change specifies that coaches are prohibited from using the device to communicate with any other team member while on defense or any team member while on offense and the coach cannot use the device outside the dugout/bench area.

9-3-2b: When a baserunner who is declared out for being hit by a fair batted ball, the batter-runner is credited with a fielder's choice in the scorebook.

2025 NFHS Softball Points of Emphasis:

PACE OF PLAY:

Coaches play a vital role in creating and maintaining pace-of-play standards for their individual players and teams. Every effort should be made to educate players on the rules involved and the timing protocols related to breaks between innings, as well as during gameplay. Between innings, 60 seconds is provided for (a) the defense to take the field and throw warm-up pitches, and (b) the offense to prepare to bat.

- There are several ways that coaches can expedite this process with simple instructions to players. For example, if the catcher was batting when the third out was made, have another teammate or coach prepared to receive warm-up pitches while the catcher gets equipped. For the team coming to bat, coaches should encourage their lead-off batter to gather their batting equipment while the remainder of the team huddles in an appropriate area that doesn't pose a safety risk for the defense warming up.
- There are prescribed penalties associated with excessive time between innings. Once the allowed 60 seconds has passed, the offensive team has 10 seconds for its batter to enter the batter's box (NFHS Rule 7-3-1). Similarly, once the allowed 60 seconds has passed, the pitcher has 20 seconds to legally deliver a pitch (NFHS Rule 6-2-3). These same time constraints exist on each pitch thrown. Once the ball has been returned to the pitcher to prepare for the next pitch, the pitcher has 20 seconds to release the pitch. Coaches who delay in calling pitches risk a penalty for exceeding the allowed 20 seconds. The same applies to the offense when a batter fails to enter the batter's box within 10 seconds after the ball is returned to the pitcher. The respective penalties for violations of these time constraints are either a strike or a ball on the batter, depending on the tardy party.
- And finally, pregame lineup exchanges should be brief and to the point. In order to start games on time, both umpires and coaches should limit talking to pertinent information during this meeting. Remember, this is not meant to be a rules clinic.

SITUATIONAL AWARENESS:

- Participant well-being should be a priority for all those involved in game management. Coaches and umpires can help minimize risk and injury to players by understanding and enforcing existing bench and field conduct rules. NFHS rules stipulate that once the game has begun, only the batter, runner(s), on-deck batter, coaches in the coach's box, bat/ball shaggers or one of the nine players on defense are permitted to be outside the designated dugout/bench or designated warm-up areas (i.e. batting cage or bullpen).
- Additionally, during game play, hitting the ball to teammates on defense is prohibited.
- Between innings, bench personnel are permitted to engage in throwing and running activities.
- Field structure and dugout protection vary from facility to facility. Team personnel should assess and be aware of potential hazards associated with foul balls and overthrows. For example, if a bullpen is in an area where a foul ball or overthrow could contact the pitcher or catcher, the team might assign bench personnel with a glove to stand nearby to shield those warming up.
- On-deck batters should be mindful of potential foul balls and overthrows and be prepared to move as necessary to avoid contact. On-deck batters may move to use the on-deck circle opposite the open batter.

JEWELRY, EJECTIONS, INTERRUPTED CONTEST PROCEDURES

<u>Jewelry</u>

The elimination of the jewelry rule will permit players to wear these items freely, Additionally, with that freedom to wear jewelry, note that any jewelry that contains profanity, taunting, language to intimidate or baiting an opponent would not be allowed under our sportsmanship rule. Besides those examples, there is existing rule coverage that gives guidance on any player equipment that presents a danger to the player, teammate, or opponent.

<u>Ejections During a Doubleheader and Out-of-State Ejections</u> <u>https://www.osaa.org/docs/planbooks/sblplan.pdf</u>

Multiple ejection reports came through the OSAA office last season where a player or coach had been ejected in the first game of a doubleheader. A reminder that when this happens, the player or coach is done for the rest of the day (**Ejection Period**) and is also suspended through the next contest at that level of competition (**Suspension Period**). Some schools have mistakenly thought that the 2nd game of the doubleheader counts as the suspension period.

- a. Example #1 A <u>varsity</u> coach is ejected in the first game of a doubleheader. The coach is done for the rest of the day (**Ejection Period**). The coach is also suspended through the next <u>varsity</u> contest (**Suspension Period**).
- b. Example #2 A <u>JV</u> player is ejected in a game on Friday (single game that day) and the <u>JV</u> team has a doubleheader the next day on Saturday. The player is done for the rest of the day on Friday (**Ejection Period**). The player sits

out the 1st game of the Saturday doubleheader (**Suspension Period**) but is eligible to play in the 2nd game of the doubleheader on Saturday.

Remember that when a player or coach is ejected from an out-of-state contest, OSAA ejection policies still apply. It is the responsibility of the school to notify the OSAA of the out-of-state ejection. http://www.osaa.org/docs/sbl/sblplan.pdf

Postponing/Canceling Contests

On the day of a contest, schools are able to change the status to either Postponed or Cancelled by selecting the appropriate box in your editing window. When postponed is selected, schools have the option to list the new date/time, if known. If a postponed contest will be replayed but you aren't sure when, you can leave the new date/time field blank to complete at a later time. If you aren't sure if the contest is going to be replayed, it should be Cancelled. That way you can always reinstate the contest if you end up being able to get it scheduled. Deleting contests from your schedule and adding them back later in the season may result in contests not counting in the rankings based on the following policies. When in doubt, leave it on your schedule as Cancelled.

Adding Contest to Schedules After Certain Dates

Contests added to a team's schedule after the dates listed below may not count in the rankings based on new Board Policies regarding the rankings. Be sure that you don't delete contests from your schedule, but instead use the Postpone Contest or Cancel Contest button to keep the contest on your schedule.

- a. Adding Contests to Schedules vs. Teams More Than One Classification Away After April 9th

 Remember that results from contests added to a team's schedule after a certain date each season (Spring April 9th) vs. a team more than one classification away shall not be included in the rankings.
- b. Adding Any Contest to Schedules After April 16th

Results from contests added to a team's schedule after a certain date each season (Spring – Apr. 16th) shall not be included in the rankings. **NOTE**: Contests not affected by this policy include bracketed contests at tournaments, league tiebreakers, and district/league tournaments. Schools may apply for an exception to OSAA Staff in extenuating circumstances.

Tracking Out of State Opponents

Out of State Records Management

Varsity teams are required to update their schedule and results through the OSAA website throughout the season. Schools are also required to track records of out of state opponents. Each Oregon school is ultimately responsible for making sure their own schedule and results are accurate, including the records of their out of state opponents.

Home/Away Designation

- a. Baseball and softball contests, even those played as part of a tournament, <u>shall not be listed as neutral</u> due to the fundamental difference associated with being the home team in those sports (advantage of batting last).
- b. **Doubleheaders:** If a team is playing a doubleheader at another school, both contests should be shown as away contests on the schedule to accurately portray where the contests are physically taking place. When scoring the contest, schools are able to check a box if the "home" team batted first so the home/away designation is correct for the rankings.

It shall be the responsibility of each member school to submit varsity team sport rosters to the OSAA through prior to the first contest date of that sport's season. Varsity rosters are required for the following OSAA sanctioned sports: football, boys' soccer, girls' soccer, volleyball, boys' basketball, girls' basketball, softball. Subsequent changes to each varsity teams' roster shall be updated as they occur throughout the season.

select which team they would like to nominate. At the end of each season, the committee chooses a winner for each sport. That program is given a banner to hang in the gym and earns 100 OSAA Cup points for their school.
